### **Defect Description:**

Jaguar Land Rover North America, LLC (Land Rover) is recalling certain model year 2014 Range Rover and Range Rover Sport and 2013-2014 LR4 vehicles manufactured September 16, 2013, to June 30, 2014. In the affected vehicles, the Tire Pressure Monitoring System (TPMS) may fail to learn the locations of the individual sensors while the vehicle is being driven. As a result, the low tire pressure warning light will illuminate, despite the the tire pressures being within specification. Should one of the tires subsequently lose air pressure, the driver would not be notified of the change in air pressure.

#### **Defect Consequences:**

If the TPMS light illuminates because the sensors cannot be located, it could mask an actual low tire pressure condition, possibly resulting in tire failure, increasing the risk of a crash.

#### **Corrective Action:**

Land Rover will notify owners, and dealers will update the Body Control Module (BCM) software, free of charge. The recall began on November 6, 2014. Owners may contact Land Rover customer service at 1-800-637-6837, Option 9. Land Rover's number for this recall is P050.

July 28, 2023	Colorado	Colorado residents replace their windshields more than other states. The reason is that Colorado is storm central for hailstorms. Unfortunately, the state also claims the 5th slot on Google Trends list of the states with the most car problems. Along with windshields, drivers experience a lot of flat tires and cars that won't start.  Colorado has a population of 5,758,736 that travels 54,634 million miles annually. The state sees about 544 fatal car crashes per year, resulting in almost 600 deaths. In addition, insurance companies get about 125,000 claims per year for hail damage due to the prevalence of stormy weather. Colorado ranks 47th in terms of poor pavement quality on highways. These crumbling roads lead to flat tires, alignment issues, dings, windshield repairs, and other vehicle damage. Most Coloradans have to spend a good deal of time in their cars commuting to work, and traffic congestion is a serious problem. The state ranks 37th nationwide for congestion issues. Colorado only has three highways, but they are also in poor condition.  Colorado ranks #6 on Forbes list of the worst states to own a car in. Most of the time, Colorado is cool and dry, with an average temperature of 43.5 degrees. The state has very little rainfall (far below the national average), so floods are not a problem for car owners. However, the state does experience some pretty violent thunderstorms during the summer hence all the hail damage.

June 27, 2016 Illinois

Illinois residents deal with a lot of cars that won't start. In fact, they are third on the list for that problem. Illinois ranks number 16 on Google Trend's list of the states with the most car problems. The most significant issues along with cars that won't start are dead batteries and tire repairs. In addition, Illinoi residents suffer a standard number of car accidents that cause vehicle damage.

Illinois has a population of 12,671,821 residents. These residents drive about 107,525 million miles per year. The state sees just under 1,000 (938) fatal car accidents annually, accounting for 1,009 deaths total. Roughly 4% of the state's highways are in poor condition. However, 8% of the state's bridges need repairs or replacement. Bad roads and bridges can cause accidents, flat tires, suspension damage, and broken windshields. Illinois also gets a lot of violent weather, which results in more than 50,000 hail-damaged cars per year. Illinois has four main highways totaling about 400 miles in length. A lot of the travel in Illinois is city driving, meaning congestion, increased fuel consumption, and time wasted.

Illinois falls smack dab in the "salt belt," meaning a state with rough winters and road salt that causes rust on vehicles. Illinois has some wildfires, although not a lot, so fire-damaged cars are possible within the state. Illinois is not a state with a lot of floods. However, Illinois does have its fair share of violent weather and hailstorms causing significant damage to vehicles.

Wisconsin car owners have trouble with them not starting. It's probably during the frigid winter months when the temperature is below zero. However, Wisconsin still shows up on Google Trend's list of the states with the fewest car troubles. Some things to go along with cars that won't start are dead batteries and flat tires. Nevertheless, Wisconsin grabs the number nine slot on Forbes' list of the best places to own a car.

Wisconsin has a healthy population of about 5,822,434 residents. Annually motorists drive 66,348 million miles in a year. The state sees roughly 526 fatal car accidents every year, with 566 resulting deaths. Wisconsin highway travel has increased by 42% since 2000. Much of the driving done in Wisconsin is on the state's highway system. Just under 15,000 vehicles are damaged in hailstorms in Wisconsin every year. The state ranks number 38 in terms of roadway maintenance and bridge upkeep. The pavement is in rough condition in some areas resulting in potholes and flat tires, broken windshields, and other damage to vehicles. The state's bridges are also in rough shape. Wisconsin considers a vehicle a total loss when the damage equals 70% of the fair market value.

Wisconsin's climate is continental humid, which means humid summers and cold, very snowy winters. A lot of snow means accidents and damage to vehicles. Plus, snow and ice equal salt on the roads and rust. However, Wisconsin is not a flood or wildfire state, so residents don't have to worry about damage to their cars from fire or water. The state does get a healthy dose of hailstorms, and about 15,000 vehicles are damaged per year that way.

Founded in 1948 in the United Kingdom, Land Rover is owned by the multinational car manufacturer Jaguar Land Rover. The company is known for its off-road vehicles, in addition to receiving both a Royal Warrant from King George VI in 1951 and the Queen's Award for Enterprise in 2001.

The first automobile manufactured by Land Rover was the Series 1, which was an attempt to fix the mechanical problems that head designer Maurice Wilks saw in the Willys-Overland Jeep. A boxy four-wheel drive vehicle with a canvas roof, the Series 1 was originally priced at £450 in 1948, or \$532 USD (the equivalent of \$5,981.58 in current value). Today, Land Rover makes a variety of SUVs and all-terrain vehicles, including the 2023 Range Rover and Range Rover Sport, along with the Velar, Evoque, Discovery, Discovery Sport, Defender 90, and Defender 110.

In 2021, Land Rover announced a plan it calls "Reimagine", which lays out its structure for electrifying all brands under the Jaguar Land Rover umbrella. In the near future, the company intends to create six all-electric vehicles in its popular Range Rover, Discovery, and Defender model lines. This builds on the several plug-in hybrid models Land Rover currently has in its portfolio. In addition, the company said that its first all-electric model will be released in 2024. The company also intends to have 60% of its vehicle lineup be electric by 2030, and by 2039, Land Rover will no longer sell any vehicle model that produces any type of emissions.
